A. LAND DEVELOPMENT PLAN REVIEW AND INSPECTION FEES

Concept/Sketch Plan	\$500
Preliminary Plat/Site Plan	\$500 or \$10/lot, whichever is greater
*Residential Water Plan Review.....	\$750 or \$15/lot, whichever is greater
*Residential Sewer Plan Review.....	\$750 or \$15/lot, whichever is greater
*Commercial Water Plan Review.....	\$750 or \$15/acre, whichever is greater
*Commercial Sewer Plan Review.....	\$750 or \$15/acre, whichever is greater
*Wastewater Lift Station and Force Main Plan Review...	\$1,000(Duplex pump station) \$1,500 (triplex pump station or larger)
*Oil and Grease Separator or Grease Trap Plan Review...	\$500
*Pre-treatment Plant Plan Review.....	\$1,500
*Residential Stormwater and Roads Review	\$850 or \$15/lot, whichever is greater
*Commercial Stormwater and Roads Review	\$850 or \$15/lot, whichever is greater
Stormwater Inspection.....	\$50 each inspection
Final Plat.....	\$350 or \$7/lot, whichever is greater
Minor Subdivision (Exemption Plat)	\$250
Soil Erosion & Sedimentation Control Monitoring and Enforcement.....	\$150, or \$40 per disturbed acre (whichever greater)

*All re-reviews for water and sewer will be charged at the rate of 50% of the original fee
 * All re-reviews of stormwater plans shall be charged as follows: \$750 for the 2nd review and \$600 for each subsequent review thereafter

B. BUILDING PLAN REVIEW FEE

New Commercial, Office, Industrial or Multi-Family construction
 \$250 - up to 50,000 square feet
 \$500 - 50,001 square feet to 100,000 square feet
 \$750 - 100,001 square feet and up

Mobile Homes

Minimum	\$350
Permit.....	\$0.15 per sq. foot
Pre location	\$50
Installers permits.....	\$50
Relocation permit.....	\$.15 per square foot + \$50 for installer permit
Set up Permit.....	\$20
Certificate of Occupancy	\$150

Storage Buildings/Greenhouses/Garages

Without Floor.....	\$.06 per square foot (\$25 minimum)
With floor.....	\$.09 per square foot (\$75 minimum)

Shop Building

(Enclosed building or enclosed pole barn)

Without floor.....	\$.20 per square foot
With floor.....	\$.025 per square foot

Open type sheds

(No walls, pole barn)

Without floor.....	\$.03 per square foot
With floor.....	\$.05 per square foot
