Peddler License Application

1. Three letters of recommendation from reliable property owners in the county in which the business is to be conducted. If the business expands into two counties, then six letters of recommendation are required, etc;
2. The place or places in the city where the proposed business will take place and the length of time during which the said proposed business will be conducted;
3. Copy of Driver's License and Social Security card;
4. Proof the applicant is at least 18 years of age;
5. A statement of the nature, character, and the quality of the goods, ware, or merchandise to be sold or offered for sale by the applicant in the city; the invoice quality of such goods, ware, and merchandise; where the goods or property to be sold are manufactured or produced; and where such goods or products are located at the time the application is filed;
6. A brief statement of the nature of the advertising being done;
7. A copy of a bond for the proposed business, in the amount of \$5000.00 per cart and/or truck;
8. The name and permanent address of the applicant's agent for service of process or an instrument nominating and appointing the City Clerk/Treasurer in the absence of another agent, as the applicants true and lawful agent with full power and authority to acknowledge service of notice of process for and on behalf of the applicant;
9. Such other identification and information necessary to discover the truth of the matters required to be set forth in the application.
10. The applicant must receive a certificate from the Health Department granting approval to operate in every county the applicant plans to operate in.
